# India will become the first country to make non-financial audit mandatory..

India will become the first country to make non-financial audit mandatory for companies of certain class. The audit, also known as secretarial audit, will ensure that all listed companies and public limited companies with paid-up capital of at least Rs 50 Cr. or public companies with a turnover of at least Rs 250 Cr. comply with all sections of Companies Act 2013. The step is part of government's effort to improve governance and transparency in Indian companies to provide comfort to foreign investors.

# Taxpayer Info to Remain Confidential.

The identity of taxpayer who opt for an advance pricing agreement (APA) in the field of transfer pricing will continue to remain confidential. Such information will not be available under the provision of Right to information Act (RTI) according to Centrl Information Commission (CIC). # Vijay Mallya Vs. Enforcement Directorate, Min. Of Finance(SC)(13

Foreign Exchange Regulation Act, 1973 Sections 40 & 56

July, 2015)

Held: The appeal is required to be dismissed for more than one reason. The fact that the adjudicating officer chose to drop the proceedings against the appellant herein does not absolve the appellant of the criminal liability incurred by him by virtue of the operation of Section 40 read with Section 56 of the Act. If the factual allegations contained in the charge are to be proved eventually at the trial of the criminal case, the appellant is still liable for the punishment notwithstanding the fact that the presence of the appellant was required by the adjudicating officer in connection with an enquiry into certain alleged violations of the various provisions of the Act, but at a subsequent stage the adjudicating officer opined that there was either insufficient or no material to proceed against the appellant for the alleged violations of the Act, is immaterial.

#### Income Tax Officer, TDS Vs. Nokia India Pvt. Ltd.(ITAT-Delhi)(8 July, 2015)


Held: Olof Granlund merely provided services to ensure that the HV AC, Electrical and Fire Protection systems to be installed at the respondent's factory in Chennai are of the right design and quality. The scope of work performed by Olof Granlund clearly lays down that Olof Granlund shall be responsible for providing following quality and design control services to the appellant. Holding meetings in India and Finland, in connection with the above. The payments received by Olof Granlund from the respondent for provision of services are not liable to taxation in India under the narrower provisions of the India-Finland tax treaty. the question of deduction of tax at source on the impugned payments does not arise. Appeal dismissed.



# Commissioner Of Service Tax Vs. Japan Airlines International Co. Ltd. (HC-Delhi)(20 July, 2015)

Institution of an appeal, authorised by the Collector, based on a note placed before him, was assailed, the Supreme court repelled the challenge based on the rationale that such authority was given to the Collector to ensure that frivolous and unnecessary appeals were not filed. The Supreme Court ruled, that as long as there was an application of mind (by which it did not mean separate reasons) in respect of the issue qua which the appeal arose and due authority was given by the Collector, the appeal was competent. On these grounds, the Supreme Court reversed the judgment and order of the Tribunal.
